- Holding the Headteacher to account for the educational performance of the school and its pupils and the performance management of staff
- Overseeing the financial performance of the school and making sure its money is well spent.

Chair's Statement

Once again, in this academic year, we have encountered a National Lockdown and the need to move the majority of our children into remote learning. The pandemic has touched many of our lives in such drastic ways and given us all so many challenges, but I am proud to say that the whole school community has risen to these challenges.

As a Governing Body we have held most of our meetings and usual business remotely and have become better skilled in this area. Ms. Slater and the staff have worked tirelessly to complete risk assessments and put procedures in place to minimise the risks for all in school. Our wonderful children and their families have also played their part, whether they were children of key workers in school or having to stay home during the Lockdown. I would like to thank everyone for everything they have done to keep learning moving forwards, it has been a great team effort.

As a Governing Body we strive to continue to support the work of the school and the importance of quality first teaching. We have worked together in our strategic role this year:

- To oversee the provision of homeschooling for many pupils and in-school provision for children of key workers
- To ensure pupils enjoy school, feel confident and are able to handle difficult situations as part of the school and wider community
- To ensure clarity of vision, ethos and strategic direction; which, with support, we plan to re-focus next year
- To ensure pupil progress is monitored and maximised
- To oversee and approve the school's budget
- To ensure that funding provided for specific purposes is used effectively e.g., Pupil Premium grant, Catch Up grant and PE and Sports grant
- To ensure the staff are supported and their wellbeing is given careful consideration
- To oversee policies which shape the culture of our school and in particular this year the introduction of a revised Behaviour Policy with a clear focus on the positive.

By carrying out our strategic monitoring role, we enable the senior leadership team to focus on the day to day running of the school. Much of our work centres around the school development plan albeit with adaptations this year to respond to and allow for the impacts of Covid.

In line with this, we regularly review our roles and the contribution we have made to the school. We hope to be able to provide more face to face support from September 2021 onwards.

We continue to review policies and procedures to ensure that these are fit for purpose and meet not only our legal responsibilities, but also our vision and aims for the school and our pupils. The children and staff remain at the forefront of our decisions as we endeavour to provide the best educational environment for them.

We continue to closely monitor the school budget. We strive to ensure we have the right staffing levels and resources so that the children's learning and development continues to be of the highest standard.

The school development plan for 21/22 will be approved by the Governing Body in the Autumn term as part of our cycle of continuous school improvement.
